#### Note:

- 1. As per provision of DCS Act and Rules, the defaulter members are not eligible to contest the elections, but they are entitled to cast their votes except those members against whom decree has been issued under section 71. However, in case, if they make the payment of their amount in default before the date of filing of nomination to the society and produce the proof thereof before the election officer, they will not be treated as defaulters an shall be allowed to contest election. It is further informed that no person shall be eligible to contest if he incurs disqualification as laid down under Rule of DCS rules, 2007. Candidate or his representative who wants to be present at the polling station shall only be allowed if presents the negative Covid-19 test report of ICMR Approved Lab and the test should not be older than 48 hours. (We be following any Change in Covid-19 protocol notification by Government).
