The Nomination Forms can be obtained free of cost from the office of the undersigned on date and time mentioned above. Nomination forms should be handed over to the undersigned by the candidate personally or by his/her proposer or seconder on the date and time mentioned above together with the cash security of Rs. 2000/- (Rs. Two Thousand Only). In case the contesting candidate gets less than 1/6<sup>th</sup> of the total votes polled, the security deposit shall be forfeited and such candidate shall be disqualified from contesting the election in that society for a period of 3 years. No person shall be eligible to contest election on two seats simultaneously. The proposer and seconder shall not be a defaulter. **If the defaulter is the proposer, its surety will also be included in the defaulter list.** A member shall not be eligible to contest for the election if he has not completed minimum period of one year from the date of acquiring membership in the Society to the date of filing of the nomination.



The list of members along with the of defaulter members of the aforesaid society shall be displayed at the office of the undersigned and notice board of the society for information of the members. Interested members can obtain the membership list from the society's office against payment of prescribed fees, as per of D.C.S Rules, 2007 (as amended from time to time).

**Special Note:**

The meeting shall start on 27/02/2022 at 01:00 PM Plot No RB-2, II<sup>nd</sup> Floor, POCKET-3, SECTOR-7, Dwarka, New Delhi – 110075 and the quorum of the meeting will be observed at 01:15 PM. In case of the quorum is not completed upto 01:00 PM on the same day i.e 01:15 PM. The adjourned meeting shall take place at the same place to conduct the election of the managing committee of the aforesaid society. In the adjourned meeting no quorum shall be necessary. **Note:**

1. As per provision of DCS Act and Rules, the defaulter members are not eligible to contest the elections, but they are entitled to cast their votes except those members against whom decree has been issued under section 71. However, in case, if they make the payment of their amount in default before the date of filing of nomination to the society and produce the proof thereof before the election officer, they will not be treated as defaulters and shall be allowed to contest election. It is further informed that no person shall be eligible to contest if he incurs disqualification as laid down under Rule of DCS rules, 2007. Candidate or his representative who wants to be present at the polling station shall only be allowed if presents the negative Covid-19 test report of ICMR Approved Lab and the test should not be older than 48 hours. (We be following any Change in Covid-19 protocol notification by Government).
2. All the members are requested to bring the proof of their identification by way of Pass Book of the Society, Driving License, Identity Card issued by the Election Commission of India or any other documents related for their identification to facilitate the smooth conduct of election. All members before visiting the polling station shall fill the declaration form of Covid-19, member not wearing mask shall not be allowed to enter in the polling station. **Not more than 100 members are allowed to enter polling station at a time as per schedule ( subject to passing thermal screening guidelines for covid-19)**
